Welcome to the Judicial College of Victoria's calendar of events for 2024. This Prospectus highlights the education on offer to Victoria's judges, magistrates, coroners and VCAT members for the year ahead.

The Prospectus also showcases a large, powerful mural in the heart of Melbourne's legal precinct by renowned street artist (and Honours law graduate) Kaff-iene. Painted behind Owen Dixon Chambers during the winter of 2022 and currently obscured by leafy trees on Little Bourke Street, the work speaks to the tension implicit in its title, 'The Lore and the Law'. It also encourages us to notice not just what is apparent in the everyday, but that which may be less obvious in our environment and in our work.

As Kaff-iene writes:

'I wanted the mural to facilitate conversation amongst Victoria's lawmakers; to highlight the continued conflict between First Nations legal systems and the Colonial/Australian Westminster legal system, and to encourage or provoke those with power to work towards resolving the conflict.'

As it has done for many years, this year the College is offering several programs on First Nations' cultural awareness, as well as a range of immersive educational events and twilight seminars covering key judicial knowledge, skills and professional development.

Thank you to the many judicial officers and others who generously give their expertise and time to the peer learning on offer at the College.

Contribute to discussions about the issues and challenges of workplace power disparities in high-performance working environments.

As Victoria begins to move towards Treaty, the Judicial College recognises the changing cultural and legal landscape for First Nations peoples and allies in this state.

In 2024, our First Nations Twilights celebrate First Peoples' storytelling and resilience; explores key organisations and services that act as first responders to a myriad of First Nations issues within the justice system; examines how the courts can incorporate lessons from the past into present judicial practice; and taps into an expansive view of Country's imaginative possibilities.

This series of events is presented in partnership with the Judicial Officers' Aboriginal Cultural Awareness Committee (JOACAC), chaired by Justice Jane Dixon and Magistrate Rose Falla.

5 March 2024

Ablaze: Film screening with director Tiriki Onus.

Relax into the cinematic experience of First Peoples' visual storytelling with a film screening of **Ablaze**, a feature documentary by Tiriki Onus and Alec Morgan that explores the discovery of a 70-year-old film made by Tiriki's grandfather, Aboriginal leader and filmmaker Bill Onus.

Tiriki Onus will join judicial officers for a discussion after the screening.

Koori participants across courts: Who is here to help?

In this exploration of services for First People in the justice system, key organisations will showcase their culturally specific skills and strategies to inform judicial officers about a range of available responses to the varied and diverse requirements of Koori people appearing in courts.

Inquiries, reviews, inquests:

LESSONS IN MINIMISING RISK.

Much has been written on the hundreds of Aboriginal lives lost to systemic racism and ongoing intergenerational trauma caused by colonisation. Recommendations abound: but what works and what doesn't? In this Twilight event, we hear about those caught in the crossfire, positive steps that have been taken across courts to ameliorate harm and how judicial officers can continue to make a difference within the system.

7 November 2024 Lore and literature.

This celebration of First Nations' writing and storytelling provides access into new worlds and probes our collective presuppositions about voice, authority and knowledge. With leading First Nations writers and thinkers, we explore the future of the Australian imagination when we summon those historical and contemporary influences that have previously inhabited the fringes – from where all great art originates.





This skills-based program will teach you to deliver oral reasons with competence and confidence. You will practice delivering oral decisions under the guidance of experienced facilitators.



In this workshop, you will build knowledge and skills to navigate the complexities of First Nations people's experiences of the law and promote an equitable justice system for all.


This program is essential for new appointees but all judicial officers are welcome to attend. You will learn about:

Managing jury trials is a core part of any criminal judge's work. You are responsible for ensuring a fair trial in accordance with the applicable rules and procedures, managing the experience of witnesses and jurors, and ensuring counsel comply with their obligations to the Court.

Explore key parts of the trial judge's role in managing a jury trial, including:

- empanelling and excusing jurors
- discharging jurors or the jury
- time management and scheduling within the trial process preparing for and conducting the *Jury Directions Act 2015* Part 3 'conversation'
- preparing and delivering either traditional or integrated jury directions.

Making the justice system safer for victim-survivors remains a priority for all courts and tribunals.

- the impact of family violence on children and young persons

- understanding and using the most widely used family violence risk assessment tool in Victoria – the Multi-Agency Risk Assessment and Management (MARAM) framework
- ways to appropriately communicate with people who use violence
- the nature of trauma and how it affects people appearing in family violence matters in your courtroom.



Sexual offence law is highly complex with judicial officers required to navigate law, evidence, procedure and emotion, in the context of changing legislation and evolving jurisprudence.

- Learn from experienced judicial officers and experts about the latest legal principles and practices relevant to sexual offence cases in Victoria.
- In this full-day program, you will deepen your understanding of:
- procedures to get the best evidence from complainants and vulnerable witnesses, including through ground rules hearings and intermediaries
- major areas of evidence law relevant to sexual offence cases, including hearsay exceptions and the tendency and coincidence rules

- the impact of changing legislation on the elements of offences, definitions of consent and the obligation to give certain jury directions
- how to manage the additional challenges that arise when childhood sexual abuse is not disclosed for decades.

19 July 2024 HALF DAY **Evidence essentials.**



A perennial favourite, this event provides judicial officers with the opportunity to hear from experienced judicial officers and experts on complex areas of evidence law.

Evidence law is at the heart of the judicial process. However, even when the principles are clear, the range of values attributed to multiple factors creates complexity.

Your questions will be collectively examined through scenario work and group discussion. Key topics about evidence law will be addressed, such as:

- hearsay and opinion
- tendency, coincidence and cross admissibility
- assessing probative value and prejudicial effect
- the credibility rule
- admissions.

- preparatory steps to ensure the smooth running of the hearing with practical pointers and clarity on what to do before and at the start of a hearing
- · how to evaluate the reliability and credibility of witnesses
- decision-making and unconscious bias risks arising from subconscious processes and assumptions.


An opportunity for judicial officers to learn more about the services that a person experiences while serving a Community Correction order or on parole.


Developed especially for recently appointed magistrates and coroners, this program includes theoretical and practical sessions on:
